OPEN DISCUSSION

Herta Madder (BCBH) – Herta announced Youth Community Day scheduled for 4/28/2016 at the Beaver Valley Mall. See Save the Date for more information. Also, she announced that BCBH has brochures and posters on opioid and drug addiction available. If you need additional posters/flyers, please contact Javerta Sims at BCBH 724-847-6225

Dina Ciabattoni (CoC Coordinator) – Dina announced April is Fair Housing Month, as well as Sexual Assault Awareness Month. See Save the Dates for sexual assault prevention trainings. Dina also announced that the Housing Forum will be on 5/18/16 at CCBC Library Resource Room - see attached flyer.

Elizabeth Focer-Repman (Columbia Gas) – Elizabeth announced that energy assistance has closed for the season. However, Columbia Gas and Peoples still have limited Dollar Energy funds. Duquesne Light does not have any Dollar Energy funds left at this time. Elizabeth recommended advocating for individuals in difficult situations by contacting the Social Workers at the utility companies.

Gianna Wright (Urban League of Pittsburgh) - Gianna reported that LIHEAP has just closed. She stated that Catholic Charities, St Vincent DePaul, or local churches may be able to provide assistance in the meantime.

She also announced the recent changes to SNAP eligibility. People who do not have a disability and no dependents, will be required to work/train for 20 hours/wk to be eligible for SNAP benefits. They may also volunteer for 26 hours/wk to meet this requirement. Folks will have 3 months before being notified of cutoff if they are no longer eligible. Contact Gianna at 724-846-6400 ext 31 with any questions regarding these new requirements for SNAP. She can also assist with advocating with the DHS caseworker.

Rosalyn Johnson (Franklin Center) – Ros stated that HAP funds may be able to assist with utilities since some of the CAP programs are closed for the season. The HAP guidelines are income based and match Dollar Energy guidelines. She also stated that HAP funds can assist with rent if facing eviction or homelessness.

Carl DeChellis (Housing Authority of the County of Beaver) – Carl reported on a fire that occurred on 8th floor at Eleanor Roosevelt Apartments. He commended the disaster response system in place to assist the 42 individuals who were displaced – specifically he thanked the Red Cross, DHS, and Ros Johnson. He also stressed the importance of encouraging people to obtain renters insurance.

Housing and Homeless Coalition of Beaver County

Michelle DeBord (Neighborhood Legal Svcs) – Michelle stated that the new SNAP requirement for a disability is not the same as SSI – she stated that it is looser. As such she will represent individuals in an appeal if they meet the definition and receive a SNAP shut off notice as a result of the new regulation. She mentioned that termination letters will not go out until the beginning of June. You can refer any people who you think should still qualify to Michelle. She did mention that New Castle is exempt from the new regulation.

Charlene Crawford (American Red Cross) – Charlene reported about the Red Cross's campaign to install free smoke detectors. They are canvassing neighborhoods to alert folks about the program. She also mentioned that the new code law requires smoke detectors in all bedrooms.

Rebecca Salopek (Housing Authority of the County Beaver) – Rebecca reported that LaborReady is doing a job fair on 4/20/16 at the Economy Crestview site from 10:30am - 2pm where they will be interviewing and hiring on that day. This event is open to the public. They will be holding another job fair on 4/22/16 at Morado Dwellings in Beaver Falls from 10:30am-2:00pm. The HACB will continue to partner with Labor Ready to do these at each HACB family site. Of note, LaborReady has relocated to the old Enterprise Rental in Monaca and they now offer ride sharing program for \$5. Registered sex offenders will not be permitted to attend the job fairs since they are on public housing grounds.

Morado Dwellings will be the first housing site to provide a Breakfast Program in addition to the lunch program during the summer months. It will be available in the mornings on Tuesdays, Wednesdays, and Thursdays in collaboration with Salvation Army. This is a pilot program to gauge use and effectiveness.

Reverand Swann (refreshing Springs Ministry) – Rev. Swann announced a clothing distribution drive with plenty of summer clothing for individuals of all ages. See attached flyer.

Victor Colonna (BCCAN) – Victor reports that the Housing Forum will be an interesting event to discuss: what is the CoC, the variety of affordable housing options, as well as the various supportive services offered through the Housing Authority. He states the event will also include breakout sessions. The event is designed for housing and social service providers. He reports that about 30 people are registered currently and that the space can accommodate up to 75 more. There will also be resource tables available so if you have information you would like to distribute, please bring it with you. Also if you would prefer to have your own table, reach out to Victor to coordinate.

Dina Ciabattoni - Dina reports that the Western PA CoC has created a link if you are working with a Veteran who needs assistance. Bryan Shannon at the Cornerstone is our SSVF worker who can assist veterans in Beaver County with a housing crisis. Fair Housing Month

April is Fair Housing month. Tom provided an overview of the fair housing laws. He states that The Fair Housing Act protects people from discrimination when they are renting, buying, or securing financing for any housing. The prohibitions specifically cover discrimination based on race, color, national origin, religion, sex, disability, and family composition. Tom states that he

can provide outreach and resources around the county. If your agency needs information or coloring books for kids, contact Tom and he will get them to you. Further if you have a fair housing concern contact Tom and he will guide you. He stated that if the issue is founded he will coordinate with Neighborhood Legal Services for legal representation. Tom will also be at the Youth Community Day at the mall and also providing information at Manna Soup kitchen.

PIT reports Dina Ciabattoni

Dina reports that she emailed the 2016 PIT charts out earlier this month. She asked the group if there were any questions or comments. None were voiced. Dina thanked George Beegle for his efforts to put the reports together. Dina also reported that there was in increase from last year in the total number of people in each of the 3 housing categories (shelter, transitional, permanent supportive). Dina also noted that the following numbers for seniors:

- 0 seniors over the age of 60 in emergency shelter
- 5 seniors over the age of 60 in transitional housing
- 6 seniors over the age of 60 in permanent supportive housing
- 3 seniors over the age of 60 were encountered in the outreach efforts

Carl DeChellis reported that the Housing Authority has about 1,000 units designated for folks aged 62 or older. He stated that these units have the shortest waiting lists.

Cornerstone Board Update

Dina Ciabattoni

Dina announced that the core founding board for The Cornerstone has been formed.

Dina reported that the Articles of Incorporation have been submitted to the state. She thanked everyone who completed a survey about the Cornerstone and reported that the Bayer Center is currently compiling all of the feedback to present to the board. The board is also working on pulling together the last pieces for the 501c3 application. Dina stated that she will update the Coalition on the development of the Cornerstone as its own 501c3 at each of our meetings.

SOAR update Dina Ciabattoni

Dina reminded the group that SOAR is a strategic approach to assisting individuals who are homeless with accessing SSI/SSDI benefits. Currently she is working to recruit interested folks in becoming SOAR trained. There is an online training that you complete at your own pace. Once a cohort has completed the trainings, a SOAR representative will come to Beaver County to conduct the final training in person. Ashley Mancine reported that communities who have successfully implemented SOAR developed subcommittees of those trained as well as key stakeholders. By working together this way, they extended the reach of the SOAR, worked to break down barriers, as well as provided education on the process to the general public. Ashley stated that having a representative from Social Security on the subcommittee also seemed to make the SOAR approach even more effective. Dina stated that the SOAR process can be time consuming but that it has proven to significantly increase the chances of folks being approved for Social Security benefits on their first application. Dina also reported a webinar about housing programs throughout the United States who have collaborated with SOAR trained groups and

that they are seeing not only quicker access to benefits but more stable housing achieved as a result. The webinar can be viewed at: https://soarworks.prainc.com/article/webinar-housing
Dina also stated even if you don't formally assist the person through the SOAR process, that the knowledge can help you effectively guide the person through the application process. She passed around a sign-up sheet for anyone interested in becoming SOAR trained. Interested persons should let Dina know so she can pass on the training materials and track who is training. Jamie Hinkle from VBH reported that she already started the on-line trainings and has found them to be very informative. She stated that the trainings are well presented and user friendly.

Bed Availability Dina Ciabattoni

Dina distributed the bed availability chart. See attached. She reported that Darcy Casey and Jaime Kinkead both suggest calling for updates as they expect their census to change in the coming weeks.

MaryAnn McDevitt (Women's Center) reported since chart was updated they have gotten new referrals and are close to full. For the most up to date census, call 724-775-0131.

Dina reports that some Penn State Students are doing a homeless awareness event in Quay Park in Beaver this weekend. UPDATE: The students did an excellent job of gaining permission from the Beaver Town Council as well as the Commissioners to hold this event. They engaged passers by in conversation and educated them on the number of homeless people in our county as well as the complexity of reasons that people experience a housing crisis. They also collected items and raised over a \$1,000 to donate to the Women's Center and Crossroads.
