The Beaver County Housing and Homeless Coalition Meeting is open to the public and welcomes new members to all monthly meetings.

#### OPEN DISCUSSION

Pastor Kim Rapczak (Crossroads Shelter) reported they are in need of qualified candidates to apply for the Coordinator position. This will either be 3/4 or Full Time position. Also the Crossroads board is looking for applicants for the Director position. The shelter is also in need of competent/dependable overnight staff from 12 am-7 am with a possibility of extending to 9 am. These staff must be male and the starting wage is a little more than minimum wage. Volunteers are always needed especially from 7pm to 12 am. You can contact Pastor Kim for additional details or to apply at 724.714.6203.

Eligibility requirements to apply for paid positions at the shelter include the ability to work with the population, familiarity with substance abuse/mental health issues, experience with homelessness, case management experience, a passion for this type of work, and an understanding of the unique challenges that the guests face.

**Dina Ciabattoni** announced that the Alliance for Consumer Protection is looking for a part-time office manager. Call their main office at 724-770-2078 for more information or if interested.

Rosalyn Johnson (Franklin Center) provided an update on BC On-Call located at the College Hill Apartments. Currently one family with 3 children is residing there. June had 4 families, and May had 3 families. Ros reports the program is going well. She states that so far no households affected by natural disaster have been housed there. She did report on the recent Midland fire where 3 families including 7 people were affected. She reached out to them to offer housing but so far they have declined. BC On-Call is in need of volunteers to help clean the apartments when there is turn-over. The challenge is not knowing when the apartment will turn over, so volunteers need to be flexible. Moffett House is in transition, but willing to work with Ros on the possibility of doing the cleaning.

**Karen Florence** (TRAILS Ministry) reports that they have received funding from the Patterson Foundation to resume the Beaver County ID Project to help people obtain an ID. The program will resume on 7/19. Karen pointed out that the Patterson Foundation has placed additional requirements on who will qualify so folks should expect some changes. The main criteria is that folks requesting an ID must have a legal record. Call 724-622-2859 for assistance. Also see attached for more details on eligibility requirements.

Karen also talked about their summer program for the children in Beaver Falls. They have worked to bring a traveling Black Museum to the Hope Center (918 7th Ave Beaver Falls) on 7/21-7/22. See attached. Also she announced that on Saturday (7/23) TRAILS will be having an Underground Railroad event at 3pm at the Hope Center.

**Andre West** (Friendship Ridge LTSR) announced that Friendship Ridge has officially changed its name to Brighton Rehabilitation and Wellness Center.

Dennis Sutter (Habitat for Humanity) announced that they are accepting applications for a new construction home to be located at 316 12th Ave., in New Brighton. There are requirements for potential applicants — these can be found on their website. He also announced that as of June 30th Linda Swaney retired and Denis is now the Director. Congratulations to Denis! He reported that they are looking to hire for the Restore - truck driver position. The position pays \$10 per hour with benefits and vacation. It is a full time position at 37.5 hr/wk. The schedule is Tues - Sat. The driver picks up and processes donations. Applicants must be able to lift 100 pounds. He states it is a difficult and physically demanding job but the driver never works alone. Applicants must have a clean driving record and no criminal background. Applicants do not need a CDL. They are also accepting donations but clothing, chemicals, or electronics will not be accepted.

**Charlene Crawford** (Red Cross) announced that 2nd Baptist Church in Beaver Falls is hosting a Family & Friends day this Sunday (7/17). It starts at 10am and everyone is welcome to enjoy the fellowship. There will be an informational table if you want to share brochures or information about your agency. The theme is: "You won't leave there the way you came".

**Cassie Mutkus** (ABC Associates) announced the next Town Hall meeting will be on October 28th. The theme is about prescription drug addiction and navigating the system. The focus will be on having agencies available to distribute resources about their services.

**Sue Thorn** (Pennsylvania Interfaith Impact Network) works to bring interfaith congregations together on social injustice issues. Some of their recent work has focused on: public safety, and the "Fight for 15" (which focuses on a living wage for low wage workers). She mentioned that HVHS nurses are having a 1 day strike next week. See attached for more information on PIIN.

**Sandy Hutchison** (Crossroads Shelter) is the new administrative assistant at Crossroads. Pastor Kim gave her a special thank you for her help with organization at the shelter.

#### 2016 CoC Program Competition update

Dina shared the list of current projects seeking renewals. New project ideas for permanent supportive and rapid rehousing projects are due to Dina on 7/21 by 4:30 pm. The ideas will be reviewed and if they meet HUD's criteria as well as local need they will be asked to complete a formal application which

along with the renewal applications will be due by 8/5. All applications will be reviewed by the Review & Rank Committee. The committee will use both HUD priorities and criteria as well as local priorities to rank the proposals. The committee will rank the applications into two tiers. 93% of the funding will go into Tier 1. Tier 1 projects are historically funded. Tier 2 will constitute 7% of the available funding which is a decrease from 15% last year. Tier 2 projects are at greater risk for not being funded. The available funding amounts have not been announced by HUD yet. There is a chance that Beaver County may receive a Permanent Housing Bonus which could be up to 5% of the Annual Renewal Demand amount. Please feel free to contact Dina with any questions.

#### Request for Proposals Continuum of Care PA-603 serving Beaver County, PA

The U.S. Department of Housing and Urban Development (HUD) recently released the FY 2016 Notice of Funding Availability (NOFA) for HUD's Continuum of Care (CoC) Program Competition. The CoC Program is designed to promote a community-wide commitment to the goal of ending homelessness; to provide funding for efforts by nonprofit providers, States, and local governments to quickly rehouse homeless individuals, families, persons fleeing domestic violence, and youth while minimizing the trauma and dislocation caused by homelessness; to promote access to and effective utilization of mainstream programs by homeless; and to optimize self-sufficiency among those experiencing homelessness.

As the Collaborative Applicant for the Beaver County Continuum of Care (PA-603), the Community Development Program is accepting proposals for new projects. The total amount of funding available to the CoC is estimated at approximately \$1,549,293. The portion of that total needed to fund current projects seeking renewal is \$1,475,518 and a possible additional \$73,775 may be available through a Permanent Housing Bonus.

Newly proposed and renewal projects will compete for these available funds, and the projects will be prioritized for funding by the Beaver County Review & Rank Committee. HUD will make the final award decisions based on the CoC Application score, project and agency criteria (as outlined in the NOFA), and the Review & Rank Committee's Priority Listing.

#### **ELIGIBLE PROJECTS**

The CoC may create new projects by using funds available through the permanent housing bonus or through reallocation. Only the following types of new projects will be accepted:

- a. CoCs may create new permanent supportive housing projects where all beds will be dedicated for use by chronically homeless individuals and families, as defined in 24 CFR 578.3.
- b. CoCs may create new rapid rehousing projects that will serve homeless individuals and families coming directly from the streets or emergency shelters, and include persons fleeing domestic violence situations and other persons meeting the criteria of paragraph (4) of the definition of homelessness.
