### **Outreach Event**

### Renee Speaker

### **Beaver Falls Health Mart**

### Jamie Castelucci

Jaime stressed the benefits of a family owned pharmacy versus the big box pharmacies. She reports that Health Mart focuses on the individual not the number of sales. She reports that in addition to filling prescriptions they can do compounding, fill pet prescriptions, offer autorefills, and they can prepare prescriptions in individual dose packages to help folks take the medication as prescribed thereby increasing safety and independence. She also spoke about the partnership Health Mart has with Primary Health Network. She reported that they offer special pricing for PHN patients who do not have insurance. Further, they have a pharmacist who is on call 24 hours a day and they have a pharmacist who specializes in children's medication. Health Mart can administer vaccines and they offer medication therapy management which is a review of a patient's medications to ensure there is no potential of adverse reactions. Health Mart has locations in New Brighton and Beaver Falls. See attached flyer for more information.

Kevin announced the Housing Preservation Grant (available through Disability Options Network) to make needed repairs and renovations for rural, very low and low income

homeowners who have a disability or have a household member with a disability. Kevin clarified that Beaver County is considered rural. He also stated that a disability has to impact one of 5 life functions. He reported that recipients need to secure matching funds and that DON can assist with this. Grants will be awarded up to \$1,500. The homeowner can find the contractor or they can work with DON to coordinate with one of their partnered contractors. Kevin encouraged any interested parties to call for an initial eligibility screening – 724.652.5144, ext 194. If the household is deemed ineligible, DON will work with the household to identify other possible resources to assist.

### **New Rapid Rehousing Programs**

### Jaime Kinkead

Jaime explained the new CoC funded Rapid Rehousing program that the Salvation Army will be launching in May. She reports that it will offer medium term, tapered rental assistance along with supportive services. The goal is for the household to eventually take over the full rental payment and maintain housing stability independently. She reported that the program will receive its referrals through Coordinated Entry. She expects to serve about 35 households in a year – roughly 12 households a month (depending on the rental amounts of each household). She stated that because it is a rapid rehousing program the rent should be around the fair market rate but if the rent can be demonstrated to be reasonable with local comparables it can exceed fair market rent. Jaime also spoke about the Home4Good grant that the Salvation Army received to add Rapid Rehousing support to households exiting Harmony House and who still need some support to achieve housing stability. She reports she will be hiring a case manager to work with both of these programs.

Bed Availability Dina Ciabattoni

Dina handed out the bed availability chart. She pointed out that the new Salvation Army RRH program is noted on the chart. She noted that when the program is officially open there will be several vacancies and she reminded the group that referrals for this program will have to go through Coordinated Entry. The CE scoring matrix will be adjusted for this new program.
