1. AGENDA

Emergency Shelter RFP

Lisa Signore

Lisa announced that a Request for Proposals is coming out soon for operations and essential services for a men's shelter. The funds will come from ESG and HAP and total \$62,000. ESG guidelines are very specific and applicants should ensure their proposals are in line with these guidelines. These funds cannot be used for the shelter site. Applicants should have a site or a formal agreement with a site. Once the RFP is released proposals will be due within 30 days. Dina will forward the RFP to the Coalition and partners can share it with any interested entities.

Lisa also reported that PHARE (realty transfer) is currently available through PHFA. She noted that one of their priorities this year is homelessness. She noted that PHARE funds could be used to supplement the ESG/HAP shelter funds.

Continuum of Care Competition

Dina Ciabattoni

Dina reported that the Review & Rank committee has completed their work of reviewing and ranking the projects for funding priority in the 2019 CoC Funding Competition. She noted that the Priority List is included in everyone's packets. She explained that the list has two tiers. Projects in the first tier are more likely to be funded. The full CoC application is due Sept. 30th. Dina noted that she will have a copy available for public review about a week ahead of the deadline. She will email the Coalition once it is available for review. She appreciates any input or feedback.

Home4Good Project

Dina Ciabattoni

Dina reported that the Home4Good application was submitted to PHFA on 8/29/19. One project was submitted to continue the RRH vouchers for Harmony House. Home4Good funded the vouchers last year. Dina stated that she expects to hear about this funding announcement in December.

The mission of the Housing and Homeless Coalition of Beaver County is to provide support, direction, and collaboration in effectively addressing the issues of homelessness and affordable, sustainable housing in Beaver County by identifying and utilizing all available resources.



Bed Availability Dina Ciabattoni

Dina shared the Bed Availability chart noting few vacancies. She asked the group to describe some of their struggles with locating affordable housing as a result of rents rising throughout the county. Melissa Grimes noted that an apartment that used to cost \$645 is now going for \$900. Marie noted that the hotels are remaining full making it difficult to secure rooms for emergency shelter. Others endorsed this difficulty with finding affordable housing. Dianne Funkhouser reminded the group that CareerLink provides training for the careers at the Shell Plant. And she noted that many employers are seeking skilled workers across all sectors. CareerLink can assist with this training as well. Dina thanked everyone for their input and stated that the affordable housing issue is being looked at more closely for possible solutions.

2. OPEN DISCUSSION

Stephanie Magnifico (Mental Health Association) announced their Halloween Party will take place on 10/9 in the Friendship Room. She also noted that the Men's Group occurs the first Tuesday of every month. MHA's 65th anniversary will be celebrated on 10/10 at 6 pm at Shadow Lakes. Theresa Lukes (Association for the Blind) thanked everyone for their referrals to the vision clinic. She noted that the clinic had to be cancelled at the last minute but that appointments were rescheduled for everyone and that 40 people are getting new glasses. She noted that they are still accepting referrals. And that they have a variety of ways to help someone get glasses if they are in need. She also reported that Boyers Mine is looking to hire a person with a visual disability to work in their mail room. The position pays \$15-\$16/hour. Jaime Kinkead (The Salvation Army) introduced new staff member Envoy John Barnett. He had previously worked at the Family Shelter in Pittsburgh. She also announced Project Bundle Up and Christmas Assistance will be starting soon. See attached flyers for information on how to apply. She also stated that the SA is collecting toys for Christmas.

Katrina Campbell (Choices Pregnancy Services) is holding an Open House event on 9/26 from 10:00-1:30 at 110 Christy Drive Monaca, PA 15061. Attendees will have the chance to see their mobile clinic. Free lunch from Subway will also be provided.

Marie Timpano (The Cornerstone of Beaver County) stated that they are hiring a part-time drive for 20 hours a week at \$12/hr. The driver will transport participants to out of county shelters, hotels, or for appointments related to housing and housing barriers. **UPDATE:** This position has been filled.



She also announced the first Beaver County Homeless Veteran Stand Down scheduled for 9/21/19 at the New Brighton VFW. Breakfast and Lunch will be provided. She thanked Christy Miles for her vision for this event.

She also announced TCBC's Dueling Piano fundraiser scheduled for 10/5/19. Tickets are \$25 and can be purchased at TCBC. She stated that there would raffles, food (French fry bar, sliders, and chicken strips), and entertainment.

Finally she also applauded BCBH for bringing "The Ripple Effect" event to Beaver County. She stated that it was an excellent event.

Harry Angelo (Job Training Beaver County) announced that Job Training received an Opioid Crisis Grant for health emergency job seekers impacted by the opioid crisis. See attached flyer for more information.

Dianne Funkhouser (CareerLink) announced a job fair on Oct. 24 from 10 am – 2pm. She also announced the Re-Entry Forum & Resource Fair on 9/23/19 from 1 pm – 4 pm and 5 pm-8 pm at CCBC. See attached flyers for more information on both events. She also reported that they are hiring for their Veteran Staff position.

Kevin Huwe (Disability Options Network) announced that DON services received a USDA grant to assist homeowners with repairs and modifications. Grants can be made up to \$3,000 and the homeowner needs to secure dollar for dollar match. DON services can assist with finding match dollars. This assistance is only available in certain zip codes so call 724.936.3203 to discuss eligibility.

Lisa Signore (Community Development Program) thanked George Beegle for his work with HMIS. She stated that DCED recently praised the quality of the reports that the county submits from HMIS.



2019 Review & Rank Criteria and Process

Competition as well as prioritizing all of the projects for funding. This subcommittee is made up of broad representation of our CoC partners including: child welfare, behavioral health, job training, and the CoC Coordinator. The members are regular attendees at Additionally, they each have program management experience which gives them valuable knowledge for assessing the viability of The Review & Rank subcommittee is charged with the work of selecting the new projects to submit proposals in the 2019 CoC our monthly CoC partner meetings and therefore are familiar with the programs, needs, and gaps in our service offerings.

Different tools were used to evaluate HMIS, Coordinated Entry (both CoC Bonus projects), the new RRH program, and the DV Bonus performance outcomes (exits to PH, return to homelessness rate, and increasing income), commitment to serving vulnerable Objective, standardized tools are used to score the programs. The same tool was used to evaluate the PSH and TH renewals. so as to accurately assess their unique characteristics. Objective data were used in each tool including: cost effectiveness, populations, history with addressing homelessness, and whether the program filled a unique CoC need.

applications for completeness and accuracy. She then assembled packets for the R&R subcommittee consisting of: the scoring tools, from a variety of data sources including Annual Progress Reports, Program Monitoring scores, and System Performance Measures). the project applications, detailed instructions, and a CoC Summary Report (which provides information on program outcome data All applications for both renewals and new projects were due in e-snaps on 8/23/2019. The CoC Coordinator reviewed the She delivered the packets on 8/28/19 and the members had a week to individually score the applications.

The subcommittee met on 9/4/19. They reviewed the score sheets for each program. They asked clarifying questions and the CoC Coordinator provided program specific information as well as local context. After the review, the subcommittee members had the opportunity to adjust their scores within 5 points. The scores were then tallied to create the final priority list.

The CoC Coordinator shared the priority list and the scores with the programs on 9/10/19. The list was also publicly posted on the Community Development Program, BCCAN, and HMIS websites on 9/11/19.
