## **Lisa Signore - Community Development Program (CDP):**

Carmen Wilkerson, the county's Fair Housing Officer and Housing Options Consultant is retiring on December 31, 2015. Lisa congratulated Carmen on her years of extraordinary service to the county. A Request for Proposal will be issued by the CDP in the near future to fill the positions.

## Carl DeChellis - Housing Authority County of Beaver (HACB):

HUD rejected the HACB's proposal to demolish the Mt. Washington public housing site in Beaver Falls.

Another home was recently sold in the HACB's Lease-to-Purchase program. The HACB still has 2 homes in Beaver Falls and 1 home in New Brighton that will hopefully be purchased by the current residents who are formerly HACB tenants. Lisa Signore added that money from the purchase of the homes may be used for the home improvement program to provide neighborhood stabilization.

The mission of the Housing and Homeless Coalition of Beaver County is to provide support, direction, and collaboration in effectively addressing the issues of homelessness and affordable, sustainable housing in Beaver County by identifying and utilizing all available resources.



## **Rebecca Salopek - CARES Ministries:**

The 22<sup>nd</sup> Annual Christmas Day Dinner will take place at Beaver Falls High School on December 25<sup>th</sup>. Social Service providers are encouraged to bring their organizations' promotional and resource materials to the November Coalition Meeting. Informational packets with agency brochures and flyers will be available at the Christmas Day Dinner. Santa will be distributing toys as well as new hats/gloves/scarves, dinner will be provided, and everyone will receive a new copy of the Christmas Story book. Coats will no longer be provided in order to avoid duplication of resource distribution in the county. Coalition members were asked to bring a new pair of gloves or a hat to the November meeting.

## **Charlie Crawford - American Red Cross:**

There is a change in the procedure formerly used by the Red Cross when aiding disaster victims. Based on decisions made at the corporate level, the Red Cross will now provide a Client Assistance Card to whomever is displaced. The card will be loaded with funds that can be used for lodging, food, clothing, etc. The Red Cross will no longer make arrangements for emergency motel stays. Clients will exert more accountability by making their own decisions. The Red Cross will still work closely with the Franklin Center, providing homeless documentation and making the necessary referrals.

## Norah Miller - Housing and Homeless Coalition:

Ada Milliner, Outreach Worker at Community Health Services for Heritage Valley, recently retired. Norah thanked Ada for her outstanding commitment to coordinating events where uninsured and under-insured individuals and household members could take advantage of life-saving health screenings and referrals to affordable health care. ## LIFE Beaver Melrose Place

The Beaver County Continuum of Care selected LIFE Beaver as the new administrator of Melrose Place, the permanent supportive housing program for homeless, disabled, elderly individuals. LIFE Beaver's Toni Hively explained the HUD funded-program will serve approximately 16 disabled adults at scattered sites through-out the county, under the auspices of Lutheran Senior Life. The target population includes but is not limited to nursing home eligible individuals who with varying degrees of case management are able to remain in the community. The Housing Authority is working with LIFE Beaver to help identify possible housing locations. Toni and her team look forward to working with members of the Coalition.



## Request for Proposal The Cornerstone

The Community Development Program issued a Request for Proposals for Technical Assistance and Non-Profit Development. See attached. A consultant will be hired whose scope of services will include submitting Articles of Incorporation, applying for 501c3 designation, helping establish a Board of Directors and providing strategic planning for The Cornerstone. Established in 2009 as a suite of offices for the Homelessness Prevention/Rapid ReHousing Program, The Cornerstone has expanded to include 12 separate programs/6 organizations, all targeting homeless and precariously housed individuals and families. The Cornerstone is so well known that there is a mistaken perception in the community that it is already its own entity. The goal of this initiative is to formalize The Cornerstone and in so doing, expand opportunities to provide services, manage itself and fund-raise with the same core group of people who are currently doing such a great job meeting the needs of the vulnerable population who rely on The Cornerstone's programs.

## 2015 Continuum of Care Funding Competition

On September 20, HUD announced the FY2015 Continuum of Care Program Competition was open. Beaver County will be applying for \$1,561,462 in funds to re-fund Stone Harbour, Crescent Commons, The CARL, Friendship Homes, Melrose Place, Safety Net, Julie's Place and the county's Homeless Management Information System. Approximately \$35,000 from the former Lenwood Housing will be re-allocated to an application for a new eligible supportive services-only position which will be closely tied into the county's coordinated assessment process. The county will also apply for a Planning Grant which funds coordination of Continuum of Care implementation. The competition closes on November 20, 2015.

The program is operating at 67% occupancy and the CoC would like it to be at full capacity.



### **GENERAL CONDITIONS**

## I. <u>Submission of Proposals</u>

The Community Development Program (CDP) of Beaver County has invited qualified consultants to provide technical assistance for the formation of a new non-profit for Countywide homeless and housing support services.

This Request for Proposal (RFP) contains the most definitive statement of the purpose, scope of work and conditions that CDP is able to provide. It includes all the information necessary for agencies to submit a proposal.

All offerors are required to submit <u>an original and one (1) copy</u> of their proposal(s) to Lisa E. Signore, Director, Community Development Program of Beaver County, 1013 Eighth Avenue, Beaver Falls, PA 15010 by **4:00 P.M.**, prevailing time **November 6, 2015**. **Do not bind or staple the proposal.** 

## II. <u>Project Description</u>

The applicant must provide a detailed description of the proposed services including methodology and timelines, along with a detailed budget.

## III. Scope of Services

- Provide technical assistance to all stakeholders in the formation of a non-profit 501 (c) 3 for a multi-service
  organization that focuses on homeless prevention, rapid re-housing and related supports to individuals and
  families who are faced with precarious housing issues. The consultant will work with an organizational
  development committee from the Beaver County Housing and Homeless Coalition that serves as the
  County's Continuum of Care and will provide the following:
  - Complete Articles of Incorporation through the State of PA.
  - o Complete an application for Non-profit status 501 (c) 3.
  - Conduct an organizational assessment concluding with a proposed administrative model(s).
  - Complete a process flow internally and externally as it relates to employees, consultants, partners, program participants and participants of the Continuum of Care.
  - Complete a communication plan for employees, consultants and the community, including a timeline for decisions.
  - In collaboration with the organizational development committee, create a board of directors and bylaws for approval of the Continuum of Care Steering Committee.
  - o Provide training and capacity building for the new non-profit.

## IV. Information required of each offeror

Each proposal submitted in response to this RFP will contain responses to the following:

- 1. Detailed scope of service
- 2. Detailed Project Budget
- 3. Timeline for accomplishments
- 4. Relevant agency experience in non-profit formation

## V. Budget

In preparing a budget, the provider must consider that the combined total available for all projects, including those required by the County, is approximately **\$25,000**.

## VI. <u>Selection Factors</u>

The County of Beaver will select the offeror that demonstrates the highest degree of experience and competence. Each proposal will be rated and ranked in accordance with the following criteria:

1.	Qualifications and experience with the general program and nature of services required	30 points
2.	Technical approach and understanding of the scope of work	20 points
4.	Qualification and experience of consultant's proposed staff assigned to the project	20 points
5.	Cost feasibility	20 points
6.	Participation by small businesses, Section 3 businesses, labor surplus are firms, minority and female firms	2 pts. each/10 pts. total
	Total Points	100 pts

## VII. Selection Process

The County will evaluate each written proposal and assign points to each segment or factor of the proposal in accordance with the points listed above.

Proposals shall be reviewed by the Staff of the Community Development Program of Beaver County. Following the review, a recommendation will be made to the Board of County Commissioners who will make the official selection. Interviews may be requested.

## VIII. Non Discrimination

The proposer must insure that the employees and applicants for employment are not discriminated against because of their race, color, religion, sex, national origin, disability or familial status and that requirements of Section 3 of the Housing and Urban Development Act of 1968, as amended, are met.

## IX. Other

The County reserves the right to reject any or all proposals, to waive any formality and to amend this RFP whenever such rejection, waiver or amendment is in the best interest of the County.
