# 1. OPEN DISCUSSION

**Marie Timpano** (The Cornerstone) reported that she is currently hiring a full time Housing Coordinator and a full time Receptionist. She stated that resumes can be emailed to Lakeisha Robinson at: <a href="mailto:lrobinson@CornerstoneBeaver.org">lrobinson@CornerstoneBeaver.org</a>

She also announced that she is having a diaper drive on the 21st so anyone in need of diapers can let her know.

**Natalie Meade** (Early Head Start) announced that even though the classrooms are closed the teachers are still checking in on Zoom and providing activity packets. She noted that they are recruiting students for next year. **Harry Angelo** (Job Training) announced that even though their offices are closed they can be reached via phone and email. He noted that they are still working to place students (aged 18-24) at work sights. The number for Job Training is: (724) 728-2020.

**Katrina Campbell** (Choices Pregnancy Services) reported that they are still seeing clients 3 days a week. They are scheduling patients one at a time. They are continuing to do sexually transmitted infection testing, pregnancy testing, and sonograms. She stated they have PPE for staff and patients. She also noted that they have diapers. Folks can call to arrange pick up. Marie noted that their driver can assist with delivery if needed. Katrina stated they are not able to provide mobile services at this time.

**Adam** (Southwood Family Based Services) noted that they are still rendering services in the home for about 85% of their families. They are using PPE and giving PPE to clients. Staff are following best practices of washing their hands in their cars, and screening clients for symptoms prior to going into the home. He reports that Southwood is about 1 in 3 agencies



who are continuing their family based services in the home at this time and it has been quite the challenge. Dina thanked him for their service and noted how grateful those families must be to have their supports continue during this challenging time.

**Kevin Huwe** (DON Services) announced that DON Services received a grant from the Federation of Independent Schools Alumni to support any person with a disability who has needs related to the Covid-19 pandemic. The grant can support up to \$500/household and can be used for food, items needed around the house, appliances etc as long as the need is related to the impact of the pandemic. Folks can apply by calling Melissa Ann at DON Services at 724.698.1817.

He also noted that the USDA home modification program is still available. He noted that the program has served 9 households in Beaver County since partnering with Marlene at the Community Development Program.

**Paul Lebanik** (St. Vincent DePaul) noted that Catholic Charities has diapers available. Contact St. Vincent DePaul if in need.

**Norah Miller** (Crossroads) noted that Crossroads is still delivering service to men through outreach, referrals, and gift cards. She reported that there are currently two unsheltered men in Beaver Falls. She states that any in need of shelter and supports can contact Crossroads for assistance by calling 724.846.1303. She also reported on the Great Parish Grouping food distribution initiative in Ambridge. This is a multi-parish effort that operates out of Good Samaritan Parish at 8th and Melrose. The entire parking lot behind the Church is the staging area for food drop off and distribution. The hours of operation are 10:30 to 1 pm every day of the week including weekends. The distribution is open to anyone who needs food. There are no income requirements and participants do not have to reside in Ambridge. She noted that hot food and perishable food items are donated twice a week from Costco and several times a week from Giant Eagle. Bag lunches are available very day. If you would like to make a donation you can do so during the same hours of operation. See attached for more information.

**Kristy Minton** (CYS) announced that the emergency housing position which has been vacant since Marsha Malesky passed away, has been filled by Amy Fredericks.

**Dina Ciabattoni** (CoC Coordinator) shared an update from Duquesne Light Cap. Temporary DLC changes include: maximum grant amount is \$1,000; customers who already received a grant since 10/1/19, can apply for a another grant up to \$500; and the maximum income threshold has been raised to 250% FPIG until December 31, 2020. She also noted that LIHEAP will be reopening soon. See attached.

Dina also reported that the county received \$23,000 in PHARE Home2020 funds to employ Technical Assistance for determining a feasible location for a Men's Emergency Shelter. Dina



stated that the Request for Proposals is posted on the CDP website and that proposals are due by the end of business tomorrow (5/15).

### 2. AGENDA

### **Eviction Moratorium**

### Dina Ciabattoni

Dina announced that the state of PA extended the eviction moratorium until July 10<sup>th</sup>. It has been clarified that this only applies to households who are having trouble paying the rent. Households who are being evicted due to damages or other lease violations are permitted. Dina acknowledged Judge Mancini for considering our request to extend the moratorium locally prior to the State's decision to do so. Dina stated that any questions about eviction can be directed to Neighborhood Legal Services and Southwestern PA Legal Services. Dina also noted that this extension gives us time to implement the programming for the CARES Act funding that is coming into the county.

# **Coronavirus Relief Fund Advocacy**

### Dina Ciabattoni

Dina explained that the CARES Act has made flexible funding available to states to address housing instability and homelessness. She stated that the state of PA is positioned to receive just shy of \$5 billion. Legislators are getting ready to make decisions on how to allocate these funds. The PA Housing Alliance is advocating for them to make some of the funding available for Rental Assistance as this would assist both tenants and landlords. The HA put together information for advocates to reach out to their elected officials. In this case, they asked us to reach out to Senator Vogel. Dina stated that she would email the information to Coalition members so they can decide if they would like to take part in the advocacy effort. She reminded everyone to check with their supervisors prior to engaging in advocacy efforts to ensure it is in line with their agency's policies.

# Women's Center Response to Covid-19

### Mary Ann McDevitt

Mary Ann presented on the unique challenges the Women's Center is facing during the pandemic. She noted that shelter capacity is reduced due to social distancing practices but they are making every effort to link unsheltered clients to alternative shelter options if they do not have space for them. She stated that therapy continues to be available through telehealth. Legal advocates are still available at the courthouse for emergency PFAs. And she stated that staff are available for face to face mobile response in emergency situations. She reminded the group that stay at home orders can exacerbate a domestic violence situation by giving the abuser more power and control. She stated that they can use the PPE to restrict the person's ability to safely leave the house and that without outside supports victims can be dangerously isolated. She stressed that we should all be on alert for these warning signs and continue to refer to the Women's Center for support.

# **CARES Act funding/ public comment**

## Dina Ciabattoni

Dina noted that as a requirement of the CARES Act funding, Community Development Program has to make a special amendment to the Consolidated Plan to outline how the funding will be allocated. See attached. These proposed amendments are available for



public comment for 5 days. Comments can be directed to Lisa Signore at Community Development Program. Dina noted that the proposed amendment is currently available on the Beaver County Times (timesonline.com) in the Legal Notices. She also emailed a link to Coalition members on 5/8/2020.

Norah Miller noted that the Crossroads Advisory Board of Directors is very appreciative of the county's recognition of the need for a shelter for homeless men as indicated in the CARES Act proposed amendment.

# Bed Availability Dina Ciabattoni

Dina shared the Bed Availability chart. She noted that the Housing Authority is continuing to limit move-ins for walk-up and high rise properties. They will consider emergency needs on a case by case basis. CRS is currently not accepting new clients until the county is moved into the Yellow phase. UPDATE: Beaver County has moved into the Yellow phase. Other programs are at full capacity at this time. She noted the waitlists are rather short but mused if this meant people are just not presenting for services as much right now.

The U.S. Department of Housing and Urban Development (HUD) has notified the County of Beaver of a special allocation of funding associated with the federal CARES Act. The funding is intended to be used to prevent, prepare for, and respond to the COVID-19 pandemic. The County has been allocated the following amounts:

Community Development Block Grant - CDBG-CV: \$1,985,606

Emergency Solutions Grant Program - ESG-CV: \$984,814

Total CARES Act Special Allocation: \$2,970,420

These amounts will be added as a Substantial Amendment to the FY 2019 Annual Action Plan, Year 5 of the 2015-2019 Consolidated Plan. Input about arising needs for low- and moderate-income people related to the COVID-19 pandemic are encouraged. The following activities are being considered for funding:

- Schools Respond to COVID-19 (CD-195523)

(\$150,000+\$10,000 Activity Delivery Costs)

- Men's Emergency Shelter (CD-195521)

(\$200,000+\$18,485 Activity Delivery Costs)

# Citizen Participation Plan (24 CFR 91.105)

Revised Citizen Participation Plan regarding emergency activities and those covered under the CARES Act — Public Law 116-136. The Citizen Participation Plan is being revised to: (1) allow for a 5-day comment period and the use of virtual meetings during a local, state or federally declared disaster or emergency, and (2) to eliminate language that HUD will approve Urgent Need activities prior to the County submitting an Amendment.

Due to the urgency of the COVID-19 pandemic, HUD has issued a waiver to 24 CFR 91.105(c)(2) and (k), 24 CFR 91.115(c)(2) and (i) and 24 CFR 91.401 that allows for an expedited comment period of 5 days. The comment period will be from May 18, 2020 to May 22, 2020.

Comments on this proposed amendment should be directed to the Director, Community Development Program, 1013 Eighth Avenue, Beaver Falls, PA 15010 no later than May 22, 2020.

Copies of the County's modified Consolidated Plan, Annual Action Plan and Citizen Participation Plan will be made available upon request in writing to the above address.
