

September 10, 2020 Meeting Agenda

Welcome and Housekeeping: Dina welcomed everyone at 1:35pm. She notified attendees that the session was being recorded to assist with the preparation of minutes. Since the Housing & Homeless Coalition welcomes ideas, opinions, and knowledge from a broad spectrum of partners, meetings are open to the public and new members are always welcomed. Meetings take place the 2nd Thursday of every month at 1:30 pm in the CYS Conference Room on Zoom until further notice. Zoom meetings are recorded to assist with the preparation of the meeting minutes. The recording will not be shared or posted.

1. OPEN DISCUSSION

Michelle Medlin (Lifesteps Early Head Start) noted that they operate year round and they are still enrolling students. She stated that they work with everyone including foster parents, grandparents, etc. She stated that they are doing everything virtually at this time. She states that they send out supplies. If interested in enrolling call, 724.240.1575.

Teresa Lukes (Association for the Blind) noted that they are still doing vision screenings and distributing glasses. She stated that the screening machine places a good bit of distance between the screener and the patient. To schedule an appointment, call: 724.506.6477.

Cyndi Gilkey (Neighborhood Legal Services) reported that they are seeing landlords trying to evict for other reasons than nonpayment of rent to avoid the limits placed by the CDC eviction moratorium. In order to be covered by the CDC moratorium, tenants have to fill out a declaration form with which NLS can assist. Finally, Cyndi asked for agencies to send her any pertinent information regarding their services as NLS is working to refer people to additional services as needed. Penny Jones (landlord partner) stated that the PHFA rental relief program requires the household to be one month behind. Cyndi stated that there is a statewide push to change that regulation. Penny asked if there is anything else they can do to assist their tenants. Dina stated that she has heard some landlords in other parts of the state have started to offer partial payments and letting folks pay off owed balances over time. Penny stated that she carries information about these programs back to the Landlord Association, so they are aware of the assistance that is available. Dina thanked her for doing so and offered to speak with them as well if that would be helpful. Angela Melton from Neighborhood Legal Services stated that they hired temporary attorneys to assist with navigating the rental assistance programs and the eviction proceedings.

Nancy Greico (Red Cross) reported that there were two incidents in August. One involved a home collapsing after a car crashed into it. 2 adults and 4 children were displaced. involved a fire at the Beaver Falls Plaza. The Red Cross and the Cornerstone assisted the families. She noted that the Red Cross is deploying volunteers across the country in response to the wildfires.

Dina Ciabattoni (CoC Coordinator) had several announcements. First, she mentioned Covid-19 Crisis Counseling is available to people who are feeling overwhelmed by the pandemic. She also mentioned 2 Drive Up food distribution events. People must register in advance. Additionally, she provided info on the Caring Place which provides grief support to children and adults. Their services are now available virtually. See flyers for more information on each of these programs. Finally, she mentioned that the First Baptist Church (located at 301 Adams Street in Rochester) is providing free haircuts on Sept. 21st from 10-2:30pm.

2. AGENDA

CDC Eviction Moratorium

Dina Ciabattoni

Dina reported that the CDC has put an eviction moratorium in place for non-payment of rent through Dec. 31, 2020. She stated that the following details must be met to be eligible: best efforts made to secure government assistance for rent, expect to make less than \$99,000 this year, is unable to pay rent due to loss of income, hours etc, is trying to make partial payments, if evicted the household would become homeless, and the understanding that this does not excuse rent owed or any fees accrued. A declaration form must be completed stating these conditions and submitted to the landlord in order to be protected. Dina provided a copy of a template Declaration form. She also noted that the eviction moratorium does apply to nonpayment of rent evictions that were filed prior to the Sept. 4th moratorium as well as new cases going forward. The moratorium does not apply to other lease violations.

Veteran Stand Down Tom Kaminsky

Tom announced that the Veteran Stand Down is scheduled for November 6th from 10 am – 2 pm in The Cornerstone's parking lot at 600 6th Street Beaver Falls. Tom stated that veterans will be served first but all homeless people are welcomed to attend. He noted that they are looking for people to help plan the event as well as to be vendors at the event. Salvation Army children's programming

Jaime Kinkead

Jaime stated that they Salvation Army Corps are starting to sign people up for Project Bundle Up and Christmas assistance. She also noted that they are going to resume their children's program. This includes activities, badges, character building, and dinner. She noted that they can also provide transportation. Updates Dina Ciabattoni

Dina provided several updates.

- Home4Good Outreach Proposals are currently being reviewed.

- PHFA Rental Relief program has served 38 households, 33 landlords, and has paid out \$91,000 since the program started in July. PHFA can shift funds between counties who need more and those who need less. Applications are due by the end of Sept. but it is possible that this deadline may be extended due to the CDC moratorium.
- 2020 ESG proposals that were funded include TCBC (RRH, HP, hotels, and BC On-Call) and the Women's Center (Essential Services).
- ESG-CV funds that are currently contracted include TCBC (hotels and the homeless hotline)
- Klavon Design is currently taking a deep dive into the zoning restrictions and processes in several identified communities to determine 3 feasible locations for a men's emergency shelter by October.

Bed Availability Dina Ciabattoni

Dina noted that many programs are at capacity but that they are also working on turning units over as folks transition to Mainstream Vouchers. She reported a slight up tick on the CE waiting lists but reported the majority of folks are engaged by a program. She also explained that the CE subcommittee reviews the list biweekly to review cases of households who remain on the lists and to problem solve barriers to their housing. Due to both of these efforts, we are seeing movement on the lists.



- Please complete a reservation at pittsburghfoodbank.org/drive-up or by calling 412-460-3663 ext. 655. You will need your name, email, zip code, email address, current weekly income and license plate number for the car picking up food.
- This event will serve 500 households. There are no exceptions to one reservation getting one share of food. For one car to get two or three shares of food, the car must have more than one family or household. Each household must complete a separate reservation. The same car and license plate can be used up to three times for the same event.
- For everyone's safety and to maintain social distancing guidelines. individuals must stay in their cars at all times except to use the provided outdoor restroom facilities. Leaving cars to socialize is prohibited.
- After pulling up to distribution area, put the car in park and then unlock the trunk or backseat for food to be loaded. For everyone's safety, volunteers will not be able to load food into the cars until they are in park.
- Please do not get out of the car when food is being loaded into the car.
- Stay alert and follow the guidance of Food Bank staff and police as they direct cars through the distribution area.

I certify under penalty of perjury, pursuant to 28 U.S.C. 1746, that the foregoing are true and correct:

- I have used best efforts to obtain all available government assistance for rent or housing;¹
- I either expect to earn no more than \$99,000 in annual income for Calendar Year 2020 (or no more than \$198,000 if filing a joint tax return), was not required to report any income in 2019 to the U.S. Internal Revenue Service, or received an Economic Impact Payment (stimulus check) pursuant to Section 2201 of the CARES Act;
- I am unable to pay my full rent or make a full housing payment due to substantial loss of household income, loss of compensable hours of work or wages, lay-offs, or extraordinary² out-of-pocket medical expenses;
- I am using best efforts to make timely partial payments that are as close to the full payment as the individual's circumstances may permit, taking into account other nondiscretionary expenses;
- If evicted I would likely become homeless, need to move into a homeless shelter, or need to move into a new residence shared by other people who live in close quarters because I have no other available housing options.³
- I understand that I must still pay rent or make a housing payment, and comply with other obligations that I may have under my tenancy, lease agreement, or similar contract. I further understand that fees, penalties, or interest for not paying rent or making a house payment on time as required by my tenancy, lease agreement, or similar contract may still be charged or collected.

^{1 &}quot;Available government assistance" means any governmental rental or housing payment benefits available to the individual or any household member.

² An "extraordinary" medical expense is any unreimbursed medical expense likely to exceed 7.5% of one's adjusted gross income for the year.

^{3 &}quot;Available housing" means any available, unoccupied residential property, or other space for occupancy in any seasonal or temporary housing, that would not violate Federal, State, or local occupancy standards and that would not result in an overall increase of housing cost to you.

 I further understand that at the end of this temporary halt on evictions on December 31, 2020, my housing provider may require payment in full for all payments not made prior to and during the temporary halt and failure to pay may make me subject to eviction pursuant to State and local laws.
 I understand that any false or misleading statements or omissions may result in criminal and civil actions for fines, penalties, damages, or imprisonment.

DECLARATION UNDER PENALTY OF PERJURY FOR THE CENTERS FOR DISEASE CONTROL AND PREVENTION'S TEMPORARY HALT IN EVICTIONS TO PREVENT FURTHER SPREAD OF COVID-19

Supplemental Instructions

This declaration is for tenants, lessees, or residents of residential properties who are covered by the CDC's order temporarily halting residential evictions (not including foreclosures on home mortgages) to prevent the further spread of COVID-19. Under the CDC's order you must provide a copy of this declaration to your landlord, owner of the residential property where you live, or other person who has a right to have you evicted or removed from where you live. Each adult listed on the lease, rental agreement, or housing contract should complete this declaration. Unless the CDC order is extended, changed, or ended, the order prevents you from being evicted or removed from where you are living through December 31, 2020. You are still required to pay rent and follow all the other terms of your lease and rules of the place where you live. You may also still be evicted for reasons other than not paying rent or making a housing payment. This declaration is sworn testimony, meaning that you can be prosecuted, go to jail, or pay a fine if you lie, mislead, or omit important information.

- Eligible for the Housing Authority
