

### March 11, 2021 Meeting Agenda

**Welcome and Housekeeping:** Dina called the meeting to order at 1:35pm. She asked everyone to sign into the chat. And reminded the group that the meeting is being recorded to assist with the preparation of the minutes. The recording will not be shared or posted.

Since the Housing & Homeless Coalition welcomes ideas, opinions, and knowledge from a broad spectrum of partners, meetings are open to the public and new members are always welcomed. Meetings take place the 2<sup>nd</sup> Thursday of every month at 1:30 pm on Zoom until further notice. ### 1. OPEN DISCUSSION

**Herta Madder (BC Behavioral Health)** shared information on a Trauma Informed Care training. See attached flyer. She reminded the group that we are all at risk of vicarious trauma and highly recommended the training during these challenging times.

**Jan Davis (TRAILS – Project ID)** reported that she recently encountered a woman who ended up paying over \$50 for a birth certificate online. Jan wants the group to be aware that this scam is occurring. She reminded the group that if someone is homeless, they can get birth certificates and IDs for free. Project ID can assist folks with this process including providing rides to Vital Records in New Castle.

**Rebecca Salopek (Housing Authority and Christian Assembly)** reported that she is retiring. She noted that she will continue to work 2 days a week at the HA sites in Beaver Falls working with children age 5-10 years old. She will also continue her work with Christian Assembly. Dina thanked Rebecca for her many years of service and leadership to the community. Dina also stated that she is grateful that Rebecca will still be serving in these critical capacities. Congratulations Rebecca!

Natalie Meade (Head Start/Early Head Start) announced that they will be hosting a Virtual Community Day where families can log on to meet teachers and other staff, take virtual tours of the classrooms, playgrounds, and buses, ask questions, and fill out an application. She also mentioned that the Dads Matter program is now available in Beaver County. Dads Matter is designed to empower fathers and father-figures to shape their children's lives, enhance their relationships, and improve their financial well-being. **Nancy Grieco (American Red Cross)** reported that since our last meeting there have been 3 single family house fires which affected 6 adults (including one fatality) and 4 children. They continue to promote the installation of smoke detectors and will be targeting the community



where the fatality occurred. She also reminded the group about the importance of their virtual Emergency Preparedness training. For more info call: 1.800.REDCROSS

**Marie Timpano (The Cornerstone)** announced that Tom Kaminsky is leaving The Cornerstone to work for the Community Development Program. She thanked him for his many years of service and wished him well.

**Dina Ciabattoni (CoC Coordinator)** announced that there will be a drive-up food distribution event on 3/13 in Beaver Falls and 3/19 at Mt. Carmel Presbyterian Church in Aliquippa. ### Aetna Dual Eligible Special Needs Program

Lauren Sharkey

Lauren presented an overview of the 2021 Dual Eligible Special Needs Program. This program is for those folks who are on both Medicaid and Medicare. She highlighted that the plan also includes coverage for vision and dental as well as transportation. Also 14 days of meals are provided after a hospital discharge. ### **Emergency Rental Assistance Program**

Dina Ciabattoni

Dina shared that the ERAP will be starting soon in Beaver County. The County has been allocated \$10 million dollars that can be used for Rental and Utility assistance including paying arrears. There are no cap limitations on the amount of assistance as the previous program had. Applications can be completed on COMPASS (compass.state.pa.us). The application can be found in the lower right hand corner of the webpage. We will also make paper applications available throughout the county. Both landlords and households can apply. If your agency would like paper copies let Dina know. She reported that the County intends to contract with the Franklin Center to operate the program. **UPDATE:** The direct phone number to reach the ERAP program at the Franklin Center is 724.709.1773.



**UPDATES:** Men's Shelter; American Rescue Plan; 2021 NOFA

Dina announced that the Commissioners have selected a provider to develop and operate the Men's Emergency Shelter. She thanked all of the entities who applied acknowledging that this has been a significant gap in our CoC and she is grateful for the time and effort applicants put into trying to fill it to support homeless men. She announced that The Cornerstone of Beaver County was selected to operate the Men's Shelter. She asked Marie if she had any comments. Marie noted that she and her team are humbled and honored to have been selected. She noted that they are under contract to purchase the D&A building in Vanport. She hopes to close on the building by June and to start hiring staff then. She noted that they are working closely with the County and their planning committee to develop the shelter. She stated that she will keep everyone updated and also welcomed any thoughts or ideas that anyone has noting that this

Dina shared that the American Rescue Plan (the newest stimulus package) contains significant support for housing and homelessness including: \$27.4 billion for Rental Assistance; \$5 billion for housing vouchers; \$5 billion in homeless assistance; and \$5 billion for utilities. She also reported \$10 billion for homeowners. More information can be found here:

Dina noted that the 2021 NOFA still has not been released. She expects it to be released in late spring/early summer but it is hard to know for certain when HUD will have the new competition details updated. UPDATE: 2020 CoC Grant Agreements should be coming through in the coming weeks. If you receive one of these grants please keep your eyes open for the agreements and be sure to have your required match commitments documented.

Bed Availability Dina Ciabattoni

Dina noted that all three CE waitlists have gone down compared to last month. She also noted a few openings in Crescent Commons and the CARL. She reminded the group that these referrals have to go through CE. Additionally, Safely Home (RRH for DV households) has vacancies. She also reminded the group that the Eviction Moratorium is slated to expire at the end of the month. Although, she stated that experts are expecting it to be extended. Dina will keep you updated on whether this happens. UPDATE: The Eviction Moratorium has been extended through June. Click here for more information including the required declaration form.

### **Drive-Up Food Distributions**

### What is a Drive-Up Distribution?

These events provide individuals and families with at least 40 pounds of food in one or more pre-packed boxes. Food is loaded into your trunk or vehicle once you come through the distribution line.

### Who qualifies for assistance?

There is no required proof of eligibility and anyone is eligible for food. Your information will only be used to provide you food and help us improve your service. This information is subject to change.

### What if I don't have a car?

For the safety of those at the event, walk-ups are not permitted at drive-up distributions. If you do not have a vehicle, you may have another individual drive you to pick up food.

Each household must complete a reservation to receive food. The same car and license plate can be used up to three times for the same event. There are no exceptions to one reservation getting one share of food. For one car to get two or three shares of food, the car must have more than one family or household.

### How do I make a reservation?

Go to pittsburghfoodbank.org/get-help/drive-up/ or call the Food Bank at 412-460-3663, ext. 655. Reservations open 4 weeks before each event and close at 5 p.m. the day before the distribution. The car's license plate number is required at the time of making a reservation. A limited number of extra food shares will be available for those without a reservation on a first come, first served basis. A reservation is the only way to guarantee you will receive food.



### Where is the distribution?

See reverse for the full list of locations and dates. Most sites are served once per month.

### Please follow these guidelines:

Individuals attending the distribution must stay in their vehicles at all times. This will help us maintain six-foot social distancing. Leaving cars to socialize is prohibited.

After pulling into "distribution row", put your vehicle in park and unlock your trunk or backseat for food to be loaded. Volunteers will not load food into vehicles until they are in park.

Please wear a mask covering your mouth and nose when interacting with Food Bank staff or volunteers.

### **FACILITIES MANAGER**

### **SUMMARY:**

Working under the supervision of the Executive Director, the Facilities Manager will provide general maintenance duties at all TCBC locations and will also complete housing inspections for all TCBC programs. This is full time, 40 hours per week, non-exempt position, whose standard work day is Monday through Friday from 8:30 am to 4:30 pm. The position is primarily site-based at all of The Cornerstone of Beaver County locations, which include: 600 6<sup>th</sup> Street, Beaver Falls PA 15010 and 697 State Avenue, Vanport PA 15009.

### ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Complete all basic maintenance at all TCBC locations including but not limited plumbing, electrical and grounds maintenance.
- If work/repair required is out of the scope of knowledge/experience, notify the Executive Director and present suggested contracted providers to complete project.
- Oversee any building/maintenance projects when outside contractor is needed
- Serve as the Beaver County Fair Housing Officer
- Complete all housing inspections for TCBC housing programs.
- Complete all inspection paperwork required by TCBC funders
- Attends meetings/trainings as assigned
- Other duties as assigned

### SUPERVISORY RESPONSIBILITIES:

This job has no direct supervisory responsibilities.
